

NOMINATION FOR ELECTION AS A ZONE COUNCILLOR

Made under By-law 1, paragraph 9.2 of the By-Laws of Football Northern Territory Incorporated (the Association)

BEFORE YOU COMPLETE THIS FORM

- Zone Councillors are elected by the Registered Participants of the relevant Zone. Where a Registered Participant is under 18 years of age, their parent or guardian votes in their place (By-law 1, paragraph 4.2).
- To be eligible, a candidate must be 18 years of age or over and be nominated in accordance with By-law 1, paragraph 9.2 (By-law 1, paragraph 4.1).
- A nomination must be in writing, must be signed by both the nominator(s) and the nominee, must specify the Zone, and must be lodged in accordance with the notice calling for nominations (By-law 1, paragraph 9.2).
- Each Zone Council comprises a minimum of 6 and a maximum of 10 Zone Councillors, although a Zone Council may operate with fewer than 6 if fewer than 6 eligible persons are available (Constitution rule 4.6(b); By-law 2, paragraph 6).
- If the number of candidates is equal to or fewer than the number of positions to be filled, those candidates are taken to be elected, and the Directors declare the result. If there are more candidates than positions, a poll will be held (By-law 1, paragraph 9.4).
- Zone Councillors serve a two-year term commencing on **1 November 2026** and are eligible for re-election (By-law 1, paragraph 10.1).
